Question 1 - Local Government Election Sign Displays - Gary Page

Given:

- (a) Badger vs Bayside City Council judgement by the Supreme Court;
- (b) Local Government (Casey City Council) Act 2020;
- (c) Local Government Act 2020, Section 257(3);
- (d) a future Act of parliament changing the administration of the City of Casey;
- (e) there are people who intend to be Candidates in the next City of Casey elections:
- (f) the date of the next Local Government Election for the City of Casey could be held prior to the
- 4th Saturday in October 2024 e.g. another date in 2022, 2023 or 2024.

When can corflute signs, etc., for people who intend to stand as candidates in the next City of Casey elections be displayed on residential, commercial, sporting, council properties, or road infrastructure (e.g., see current signs in centre of Webb St and Prince Highway intersection)?

The answer was prepared by the Manager Planning and Building and read out by the Chairperson of Administrators

Notwithstanding any separate permissions required from landowners to display any sign(s), Planning legislation allows signs publicising political events to be displayed for no longer than 14 days after the event is held or for a total of 3 months, whichever is sooner.

In addition, the Casey Community Local Law 2018 regulates the placement of signage on roads and Council land, and states: A person must not, except with a permit, display or permit to be displayed a sign on any road or Council land.

This means there must be a permit obtained for each sign that is placed on any road or Council land. All permit applications are assessed against the Community Event Signage Policy. Further information is available on our website.

Question 2 - Local Government Candidate Signs - Gary Page

A permit exempt sign for a candidate for an election can be displayed with a 3-month display limit under the City of Casey Planning Scheme, Clause 52.05-10, and the Local Government General Elections for the City of Casey can be varied.

Can a series of different corflute, etc., signs for a candidate be displayed on a property (up to a 3-month limit per sign) until 14 days after the next Local Government elections for the City of Casey?

The answer was prepared by the Manager Planning and Building and read out by the Chairperson of Administrators

Only one sign may be displayed on the land at a time. The Scheme does not purport to limit the consecutive display of different signs provided it is displayed for no longer than 14 days after the event is held or for a total of 3 months. whichever is sooner.

Question 3 - Interest on overdue rates - Dale Munckton

Could you please advise the total amount of interest charged to Casey property owners for overdue 2021/2022 rates and the forecasted interest to be charged to those who have not paid yet.

The answer was prepared by the Chief Finance Officer and read out by the Chairperson of Administrators

For the first three months of 2022, there has been \$0.7 million in penalty interest charged on overdue rates, following Council's decision to freeze penalty interest on all rates in arrears from March 2020 to December 2021. The forecast for the year is subject to instalments and arrangements made in the remaining months of 2021/22, but the budget estimate for the year is \$1.9 million.

Question 4 - Refund / credit of interest charged on overdue rates - Dale Munckton

In light of the last two years and the on-going poor state of the City of Casey (mowing/maintenance) will the City of Casey agree to refund/credit interest charged for those who pay their rates by 30 June?

The answer was prepared by the Chief Finance Officer and read out by the Chairperson of Administrators

Council has frozen penalty interest on rates in arrears from March 2020 to December 2021 in light of the COVID-19 disruptions. Individual ratepayers that are experiencing hardship can contact council's officers to make an arrangement and have consideration for hardship relief, which can include the waiving of penalty interest. Whilst there has been acknowledged challenges with some services, there is no basis to refund penalty interest on rates in arrears beyond the measures already implemented.

Question 5 - Seebeck Drive Dog Park - Rex Flannery

The Seebeck Drive dog park is dusty and boring, is there any way we can have the dog park upgraded with challenges for our dogs please. I speak with dog owners who would like this park upgraded. Thank you.

The dog Park off Seebeck Drive was built in 2019. There are no current planned works at the park. Council officers will review the current condition and usage of the park to determine if there are any immediate works or future upgrades required to improve the park.
