JURY PANEL



Jill Garner

Chair

Jill took the helm of the Office of the Victorian Government Architect in 2015, stepping into the role as a public advocate for architecture and design after more than twenty years in practice.

As an architect, her practice - Garner Davis - has received numerous industry awards for delivering sensitive, crafted public and private work. As a design advisor and advocate in government, she strongly promotes the value of contextual, integrated design thinking and a collaborative approach across design disciplines.

In 2018, Jill chaired the national Committee for the Venice Architecture Biennale. She is a Life Fellow of the Australian Institute of Architects and in 2021 she was appointed a Member of the Order of Australia, recognizing her distinguished service to architecture, education and professional associations.



Shelley Penn

Shelley Penn is an architect, urbanist and Non-executive Director. Shelley is an Associate Professor at Melbourne University; and Adjunct Professor in Architecture Practice at Monash University where she is also the University Architect, advising on campus quality. She is recognised as an expert, independent design reviewer and a champion committed to advancing the quality of outcomes for all people.

Shelley is a Life Fellow of the Australian Institute of Architects, and Honorary member of the American Institute of Architects, the New Zealand Institute of Architects and the Royal Architects' Institute of Canada. In 2014 she was named an AFR/Westpac '100 Women of Influence' in Public Policy.

Through her practice, advocacy, advisory and directorship roles, Shelley is driven by an enduring commitment to improving social outcomes, and enriching culture and sustainability through the quality of the built environment. She was made a Member of the Order of Australia in 2021.



Steve Thorne

Steve is a director of Design Urban Pty Ltd. He has 25 years' experience working internationally. He has worked in the private and public sectors and was director of urban design (Victorian Government) and principal urban designer (City of Melbourne).

Steve's experience includes a wide range of architectural and urban design projects ranging in scale from: new towns, large revitalisation and regeneration projects, corporate headquarters and individual homes.

He chairs and sits on numerous Urban Design Advisory Panels. He has been a speaker at many professional and industry conferences on sustainable urbanism, design, urban structure, community safety and transit-oriented development. Steve has also won many international, national and state awards for his urban design work.



Simon McPherson

Architect/Urbanist Simon McPherson is a leading cities thinker and practitioner. He recently completed the inaugural Executive Masters (MSc) in Cities at the London School of Economics, and brings extensive experience and advanced skills in urban analysis, strategy, design and delivery. His broad portfolio of award-winning work spans policy and guidance, research, design review, strategic master planning, concept design, design advice and stakeholder engagement, in Australia and the UK. Simon established Global South in 2016, as an independent, collaborative, research-focused and public-oriented urban practice. He also founded 'Liveable', a start-up building an online tool to help people choose a more liveable, affordable and sustainable home, through detailed, personalised evaluations of potential housing choices.

Simon is also a member of the Victorian Design Review Panel, the Melbourne Design Review Panel and the South Australian Design Review Panel, and played a lead role delivering the NSW 'Better Placed' State Design Policy.



AWARDED PROJECTS



GREAT PLACES

This category, great places, recognises best practice in interdisciplinary design, development or renewal, and activation, of people centered places. The awarded spaces integrate urban design, landscape design, public art, and planting, to create rich inviting, diverse community places.

The jury was buoyed by the design consideration, quality and amenity of the various public open space entries, despite the wintry weather during their site visits. The pivotal role and value of public space in the urban environment has been reinforced for us all over the past 2-3 years, and it is exciting to see such design investment in creating places for people, within Casey's residential neighbourhoods.

Orana Park

WINNER

Orana Park provides for a rich array of experiences and interests, through effective layering and integration of diverse elements and spaces. It's distinctive, bespoke and arts-driven design extends from the rideable circuit and daring play equipment with dramatic verticality, to sculptural entry statements large and small – a truly human scale experience.

The axial entry sequence is intersected by dynamic play spaces, and an inviting and protective canopy with active and restive equipment, for a broad range of age groups and interests. The park is framed by local streets and active house frontages. The result invites social interaction and supports safety and enjoyment in this valuable public asset.



Circa 1886

Park

Circa 1886 is a verdant, inviting public open space, blending play equipment, passive enjoyment and active movement opportunities. The spaces benefit from the varied, layered planting, creating a rich array of spatial experiences.

The park is activated by townhouse frontages, and forms a promontory in the area, diverting the adjacent road around its edge, increasing its visual presence. While stronger connectivity with the nearby historic Homestead would be beneficial, the character of the park draws on this heritage landmark.

Banjo Park makes optimal use of its limited area, through layering of active and passive play spaces, water play features, topographic variation and bespoke equipment. The result is a varied, inviting, complex spatial arrangement, contrasted with a simple lawn space, and predominantly edged by streets and residential frontages.

The integration of natural wood and stone, with manufactured surfaces for safety and accessibility, invites adventurous play, and creates a distinctive, colourful focal point for this residential setting.

COMMENDATION





RESIDENTIAL DEVELOPMENT

New residential development in neighbourhoods introduces important conversations about context. Our jury looked for a sensitive design approach to working in an existing place and projects that considered the contemporary home in a way that is not business-as-usual. The inherent, long-term value of these exemplary projects, in a world where we must consider our health and wellbeing, our environment, ecology, community, and whether we are a good neighbour, makes them worthy benchmarks.

Humble House

R Architecture

WINNER

Humble House showcases an alternative approach to a home on a typical suburban block.

The brief is intelligently scaled down to the essentials for living, with spaces arranged to capture the benefits of intentionally placed gardens. It presents quietly and proudly in its streetscape, while its inward-looking courtyard model creates a home with delightful indoor / outdoor relationships, flexibility and an inherent sense of privacy and protection.

There is clear commitment to reducing long-term running costs and reducing environmental impact using rainwater, natural ventilation and solar power. This flexible, versatile design economises on space (and cost), while adding considerable quality and value.



Bloom Retirement Living

Embedded within residential streets, the Bloom Retirement Living development enables residents an opportunity for integration and connection within the community. While its architecture is modest in ambition, it is scaled to work within its context, and offers some scope for animation and passive surveillance benefits through landscaped and interior spaces visually connected to its surrounds.

Tree House is to be commended for its fundamental premise to respond to its existing site context, including established vegetation, significant oak tree and challenging topography. The design concept emerging from this contextual connection takes a light touch and the outcome is valuable for community, neighbourhood and environment. Passive House commitments highlight an important ambition shared by the client and design team.

COMMENDATION



NON-RESIDENTIAL DEVELOPMENT (UNBUILT)

Non-residential development plays a key role in large residential areas, particularly in growth areas, because these projects offer special opportunities for community and place-specific outcomes that go beyond providing services to really enrich quality, amenity, local identity and pride in place.

Narre Warren North Mosque

Designed by: Jackson Clements Burrows Architects

WINNER

The result of a high level of engagement with local community, the design for the Narre Warren North Mosque is sophisticated, place-responsive and delightful. Perhaps atypical of its type, it is a powerfully landscape-based response rather than one that treats the building as an 'object' on its site. The building seamlessly combines Moorish references such as vaulted ceilings and arches with a contemporary Australian architecture more akin to sculpture in a landscape, ensuring its carefully considered, highly specific and fit-for-purpose interiors are also spatially immersed to context. Ensuring the ambition of the design proposal is delivered in all its detail will result in an inspiring and uplifting example of design excellence. quality and value.





SUSTAINABILITY OR INNOVATION IN DESIGN

Beyond the foundational levels of sustainability that should be expected of all projects, this category recognises those that go a step further in really advancing approaches, solutions and the contributions they make. It also recognises those projects that innovate by bringing new, relevant and intelligent ideas to create excellent outcomes for people.

Narre Warren North Mosque

Designed by: Jackson Clements Burrows Architects

Commissioned by: Saarban Islamic Trust

The design for the Narre Warren North Mosque is highly place- and community-responsive, immersing the building's form and functional spaces within the topography and landscape of its site. This subverts the prevailing treatment within the surrounding area of the landscape as a flat, neutral canvas, and instead celebrates its particular character and amenity. The solution is a unique and special response to its users and their site, and offers much to sustainability as well as innovation because of this approach, which treats the design problem as a 'system' challenge best address by a holistic, enduring and resonant solution for the site as a whole. Ensuring the ambition of the design proposal is delivered in all its detail will result in an enduring, resonant and special place for Narre Warren North and beyond.

WINNER (UNBUILT)



Minta Estate Shadeways

Designed by: Urban Edge Landscape Architects & Charlton Degg Engineering
Commissioned by: Stockland

Shadeways is a simple concept with an important message, informed by environmental, ecological, health and social evidence. The pathway privileges and promotes active travel, offering a safe, shady, community experience, uninterrupted by cars. The linear landscape is likely to be a well-used connection through a built-up neighbourhood. With the right choice of species, the concept will support the city's urban forest ambitions and contribute to protecting and promoting local ecology. We would love to see this concept replicated in future estates with wider, more generous, 'looser' linear landscapes.

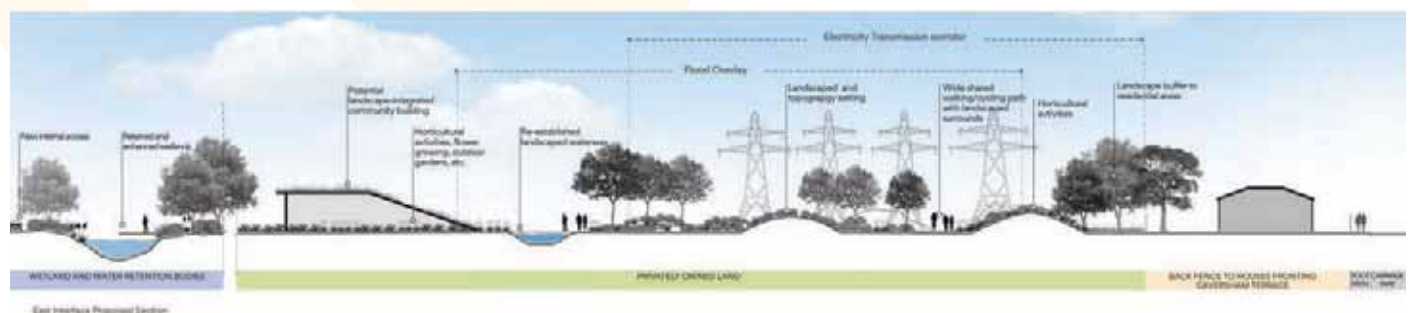
MASTER PLAN OR STRATEGY

This award recognises masterplanned developments, thriving communities and centres of jobs and growth that are designed for self-sufficiency and provide high standards of design, diversity, employment and housing choice.

WINNER

This draft Urban Design Study Report proposes a contemporary and responsible shift in the current management practice to achieve the aims of a circular economy. The jury recognised that the proposal aims to incorporate successful interfaces with adjacent sensitive residential development while proposed new developments lining perimeter roads turns outward to take advantage of exposure to these major movement corridors. This should increase activation and surveillance from the proposed new development along these movement corridors which should be of benefit to the broader urban context.
